


Financing your purchases of Norwegian products and services: How Eksfin can contribute



Eksfin offers flexible financing solutions

International buyers may consider export financing to purchase Norwegian goods and services.

Eksfin is the official Norwegian export credit agency (ECA). Our mission is to promote Norwegian exports, and export related investments in Norway.

Eksfin provides government-backed loans and guarantees to support export contracts from Norway, in cooperation with banks.



What are the advantages of export financing?

COMPETITIVE FINANCING:

Eksfin offers competitive, long-term financing in the form of guarantees and/or direct lending to creditworthy international buyers. Eksfin's government-backed guarantees have the highest credit rating (AAA).

INCREASED LENDING CAPACITY:

With the advantage of strong guarantees backed by the Norwegian state, Eksfin's participation can contribute to increased lending capacity for banks.

LONG REPAYMENT TERMS:

Eksfin offers repayment terms of up to 15 years for financing capital goods and services, and up to 22 years for renewable energy projects. Repayment term depends on useful life of the goods and services exported.

GET IN TOUCH:

ONLINE APPLICATION:

In case of lending, an application must be submitted to Eksfin before signing the export contract with a Norwegian supplier. Visit our website to submit an online application, non-binding and free of charge.

STRUCTURING THE BEST FINANCING SOLUTION:

Eksfin finances exports in cooperation with Norwegian and international banks. We will cooperate with the bank to tailor a financing solution according to the buyer's needs.

DOCUMENTATION:

To process the application, Eksfin will request information on the company and the project such as financial statements, Know Your Customer (KYC) documents and environmental and social governance.



What does it cost?

INTEREST RATES:

Eksfin offers fixed or floating interest rates on loans.

RISK PREMIUM:

Eksfin shares credit risk on equal terms and conditions with the bank(s) participating in the financing. The premium is determined by the level of risk assumed by Eksfin, depending on repayment period, buyer's creditworthiness and the buyer's country.
